The purpose of this research is to describe the management of facilities and infrastructure at the Karya Bunda Private Middle School in Medan. This research method uses descriptive qualitative research. The subjects in this study were principals and teachers. The conclusion of this study shows that the planning and procurement of facilities and infrastructure carried out by the principal is in accordance with the provisions, the inventory of school facilities and infrastructure has been carried out properly, the distribution is carried out directly and indirectly, the maintenance of school facilities and infrastructure is carried out periodically and incidentally, supervision and accountability (reporting) of school facilities and infrastructure is carried out by the principal and is carried out once a year during the new school year.

Also RI Government Regulation No. 19 of 2005 concerning National Education Standards Chapter VII article 42 paragraphs 1 and 2: (1) Every educational unit is required to have facilities which include: furniture, educational equipment, books and other learning resources, consumables and supplies needed to support an orderly and continuous learning process.

Regarding the availability of facilities such as teaching aids and learning tools, it tends to be not optimal regarding the regulation of the use and maintenance of these facilities. While learning media such as projectors are only used by some teachers.

Because not all teachers understand how to use it. The problem regarding storage places or warehouses for storing these facilities is still lacking in maintenance, so that there is a buildup of goods and even unused goods are outside the storage warehouse (Own data by observation, October 2021). Therefore, the management of facilities and infrastructure more emphasis should be placed on the institution education like school. And there must be someone who is responsible for the management of these facilities and infrastructure. By managing the existing facilities and infrastructure at the school, the principal can plan and record what facilities and infrastructure must be used in the school. If all management steps have gone well



as expected, it will have a positive impact on students in the teaching and learning process and the achievement of educational goals effectively and efficiently (Megasari, 2014).

#### Methods

This research uses descriptive qualitative research. Sukmadinata (2010) states that qualitative research is a study aimed at describing and analyzing phenomena, events, social activities, attitudes, beliefs, perceptions, thoughts of people individually and in groups.

Educational facilities are all equipment, materials, and furniture that are directly used in the educational process in schools. The process of managing educational facilities and infrastructure in educational institutions such as schools is the same in all stages. Likewise, at SMP KARYA BUNDA the management of educational facilities and infrastructure starts from the planning process for educational facilities and infrastructure, procurement of educational facilities and infrastructure, storage, distribution, maintenance, and rehabilitation.

#### Planning for Educational Facilities and Infrastructure

In the planning of educational facilities and infrastructure at KARYA BUNDA Middle School, it can be seen that there is planning for the procurement of student desks or desks, planning for buying new textbooks for students, planning for the expansion of existing rooms in the school, and planning for making parking lots for students. teacher and student vehicles.

Because any educational facilities and infrastructure needed by students and teachers to support the teaching and learning process have been planned in advance and have been mutually agreed upon by the principal, representatives of infrastructure facilities,



administrative employees who regulate facilities and infrastructure. as well as the teachers presented in the joint meeting.

In each school's educational institution the planning and needs analysis is prepared by the Planning section.

#### Procurement of Educational Facilities and Infrastructure

Procurement is all activities to provide all educational facilities and infrastructure needs. The procurement of educational facilities and infrastructure can be done by buying, renting, and receiving grants from other parties. At KARYA BUNDA Middle School, the school is responsible for the procurement of educational facilities and infrastructure.

For example, regarding the procurement of school furniture such as tables and chairs, the procurement is done by buying from companies that make chairs and tables. Meanwhile, the procurement of school textbooks can be made by buying them yourself and receiving assistance from the Government.

Sometimes there are school equipment needed by the teacher, the teacher submits it to the deputy head of the facilities and infrastructure section.

#### Storage of Educational Facilities and Infrastructure

After the procurement of educational infrastructure facilities, the storage of these infrastructure facilities is carried out. To maintain the security of the infrastructure that has been purchased, it needs to be stored properly. For storage purposes usually use a warehouse.

For this reason, every officer who manages facilities and infrastructure must pay attention to the location, provisions for the layout of goods and the construction of the warehouse building. In this warehouse stored goods that are no longer suitable for use and excess goods.

#### Distribution of Educational Facilities and Infrastructure

Distribution of educational facilities and infrastructure is an activity that involves the distribution or distribution of goods according to the needs of teachers or students for the purposes of teaching and learning activities. The distribution of infrastructure facilities is carried out with the approval of the principal who regulates how the distribution of educational infrastructure is carried out.

At SMP Karya Bunda, it can be seen from observations at the school that the newly purchased tables and chairs are given to students who excel because according to the school, in classrooms where students excel, it is necessary to provide good facilities to motivate students in learning. This is what can increase the ranking of school grades.

Meanwhile, the chairs and tables that were used from the classrooms of the outstanding students were given to the classrooms with the most damaged tables and chairs. This causes social jealousy among students. Because the distribution of facilities and infrastructure is unfair. Likewise, the classrooms for students who excel in their classrooms are made as comfortable as possible. Because the distribution of facilities and infrastructure is unfair.

#### Maintenance of Educational Facilities and Infrastructure

Rehabilitation is an activity to repair goods from damage with patchwork or replacement of spare parts so that the goods can be used again so that they have a longer service life. In addition, there are only two toilets that can function. That's why the teachers have suggested to the representatives of infrastructure and the parties who manage school infrastructure to immediately rehabilitate the toilet building. This situation is very disturbing teaching and learning activities because students have to queue first if they want to go back.
